


BEJA URBAN DEVELOPMENT STRATEGY

> Territorial delivery mechanism:

- The Alentejo region is one of the Portuguese administrative regions.
- Beja, together with the other 12 municipalities, is integrated in the intermunicipal community of Baixo Alentejo(CIMBAL).
- The strategy for Urban Development of Beja contributes to the priorities of the SUD strategy of CIMBAL and is partial supported by the Alentejo Regional Operational Programme under Policy Objective 5 and a National Fund (PRR).





BEJA: MAP OF THE INTERVENTION AREA

Beia Digital Heritage

Main theme of the strategy:

The urban regeneration of the old city centre, and strengheting Beja as a service provider, including rural areas and neighbouring municipalities.

Previous SUD Experience and New Horizon

- ➤ The 2014-2020 SUD strategy PEDU, focused on the Historical Centre of Beja, with investments in low-carbon solutions and social inclusion (information, soft and clean mobility, housing with new energies and new urban facilities).
- During the implementation of PEDU, we understood the importance of integrated interventions that can effectively stimulate dynamics for urban regeneration to revitalise of the old city and the commercial areas, as well as the need to promote housing occupation in the historic centre that with the PRR funds, were found insufficient.
- In the horizon 2021-2027, BEJA aims at a new generation of urban policies that promote the requalification of urban centres within the region, the valorisation of public spaces, rehabilitation, revitalization of the built environment and specialized functions, supporting by operations that use innovative technologies with integrated interventions that follow the paradigm associated with smart cities (decarbonization, digitalization, urban regeneration).








Strategy of SAT4SUD Results



- Productive structure of the city is the following: services 82.4%, 15.3% for industry, and 2.3% for agriculture (PORDATA, 2020)




- Title of the strategy: Jelgava local government and Jelgava municipality development program 2023-2029
- Country: Latvija
- Territorial focus: Urban neighbourhoods (district) and City
- > **Targeted population**: 93 228, including ~60 000 in City (on January 1, 2023)
- > **Funding type**: municipalities' budgets, the state budget, EU funds, other foreign financial instruments, public and private partnership, etc.
- Amount: total ~728 million €, including EU funding (currently impossible to define the precise amount)
- Policy objectives: Balanced development of technologies and skills appropriate for future needs; Enterprise competitiveness and productivity; Energy efficiency and climate neutrality; Safe and modern living environment and accessibility of territories; Innovative public administration open to the public








Strategy of Jelgava


- Territorial delivery mechanism: ITI (integrated territorial investments)
- Main theme of the strategy: Jelgava local government and Jelgava municipality development program 2023-2029 is the first common territorial development planning document of Jelgava local government and Jelgava municipality, which defines the mediumterm priorities, action directions, tasks and projects of the state city and rural territory.






Strategy of Jelgava SAT4SUD Results

- 2.4. Within the framework of our planning documents, it was difficult for us to determine the degree of necessary integration of the city and rural areas
- 4.2. In our documents, each sector was considered mostly separately, however, the main goal was to avoid contradictions and uniform development of all sectors
- 5.1. The program outlines the main goals that will be funded in the new period, but these plans do not have a specific commitment to EU funding, except for those indicated in the investment plan
